

Hello NYS-AIMH endorsed professionals!

NYS-AIMH is now accepting annual Endorsement® renewals online via the Endorsement Application System (EASy)!

As a reminder, NYS-AIMH annual Endorsement® renewal requirements are as follows:

NYS-AIMH requires all practitioners who are endorsed to:

1. Maintain membership in NYS-AIMH
2. Participate in a minimum of 15 clock hours per year of relationship-based education and training, pertaining to the promotion of social-emotional development and/or the practice of IMH
3. Participate in a minimum of 12 hours of reflective supervision/consultation (RSC) each year (IFS, IMHS & IMHM only). In order to count towards Endorsement® renewal, the (minimum) 12 hours of RSC should be over the course of at least 6-months, but not more than 12-months

To use EASy for annual Endorsement® renewal, please follow these steps:

1. Login to EASy
2. Go to your Dashboard (by going to Applications -> My Apps); you will select “Details” to update your demographic information, membership expiration date, etc.; you will then select save (bottom right-hand corner)
 - a. As a reminder, you cannot renew your IMH association membership via EASy; you will need to go here <http://www.nysaimh.org/membership/> to update your membership
3. Next, go to your Training tab
4. Once you get to the training tab, you will enter as many Training entries as needed to fulfill the 15-hour annual renewal requirement
5. Then, you will go to the Supervision tab and enter as many Supervision entries as needed to fulfill the 12-hour annual renewal requirement
6. Upon entering the necessary number of training and supervision entries, you will go to the Status tab by selecting Status
7. You will be prompted to read and agree to the Code of Ethics

In order to renew your endorsement, you must agree to the MI-AIMH Code of Ethics:



8. Then, you will be prompted to select the Submit Endorsement for Renewal button



9. Your annual renewal will be submitted to the EASy Administrator
10. You will receive an automated email from EASy that confirms that your renewal has been submitted (the email reads, *"Your annual renewal for Endorsement® has been submitted. The EASy Administrator will contact you if there are any questions about your renewal; otherwise, you will receive notice that your renewal has been approved by the date set by NYS-AIMH."*)
11. The EASy Administrator will review your renewal submission, in addition to checking to ensure that your IMH association membership is up-to-date (see requirements above)
12. The EASy Administrator will contact you if they have any questions about your renewal
13. If you successfully completed your renewal, the EASy Administrator will change the status of your application to "Endorsed"
14. You will receive an automated email from EASy that notifies you that your Endorsement® was renewed
